**Release and Indemnification Agreement
ADULTS (OVER 18 YEARS)**

I _____ do hereby indemnify, release and hold harmless the Humane Society of St. Thomas (herein after "HSSTT"), its legal representatives, directors, officers, agents and employees both in their personal and representative capacities, from and against any liability, claim, loss, expense, injury or damage to the person or property of said volunteer, or to any other persons, occurring in or about the real or omissions, its management of or any occurrence on or about the animal shelter or any adjoining street, cur, sidewalk, waterway, alley or caused by the conditions of the HSSTT or by the acts of omissions or person occupying adjoining property. I also release and hold harmless the HSSTT and its representatives from any liability, claim, loss, expense, injury or damage to the person or property arising from my actions or involvement in HSSTT activities occurring away from the above mentioned HSSSTT premises. I further recognize and acknowledge that animals of all natures and kinds, domesticated, and/or wild, are detained and/or confined on and about the HSSTT property and that such animals may be potentially dangerous to persons or property and that my presence on or about the animal shelter, is at my own risk. I also agree to compensate the HSSTT for any harm or damage that I do to any property, real or personal, belonging to the HSSTT.

I further acknowledge that the minor child shall not be permitted to enter or remain on or about the Animal Shelter unless my, or my designated agent's, direct supervision and control at all times, and that the Humane Society has no duty or obligation to supervise or otherwise control the actions of the minor child while on or about the Animal Shelter, and that the Humane Society shall be held harmless from any injury or damage to the minor child, or his or her property, which may result or arise from lack of supervision and/or control of the minor child while on or about the Animal Shelter. I also agree to compensate the HSSTT for any harm or damage that the minor child may cause to any property, real or personal, belonging to the HSSTT.
